In discussion both Paul Townsend and Zeke Ezra advised that the Constitution has in its Objectives that the Committee is responsible for the operation of the Swimming Pool (Centre). It was agreed that the investigation be directed to form a Sub-Committee, reporting to the RADSPA Committee with the specific duty to manage the operations of the Centre including the P&L and that the Centre Supervisor report directly to the Sub-Committee

There being no other items listed for General Business the Meeting held an open Forum and Q & A

Q & A

Summary

- There was general discussion on Grants and their expiry dates. The Committee is satisfied with the timing of the expenditure. Building time has been professionally assessed as 16 weeks and a start can be made once the DA is approved
- Timing of the DA before Wingecarribee Shire Council. Expecting approval before Christmas as all issues and a redo of Plans is completed and lodged. Issues on access for Wheel Chair, disabled and general public patrons have been addressed
- Questions were raised on the budgeted yearly expense of running the Centre. The Committee are working with an estimated \$100,000 per annum depending on the remuneration of the Supervisor. That salary and the cost of electricity were the two big factors
- In answer to estimated patrons the Committee indicated that 300/350 patrons per week
 would be necessary to break even. It was pointed out that the Committee had plans for a
 Contingency Fund of approx. \$100,00 to cover any shortfall during the first two years of
 operation
- Questions were asked re additional fund raising and further grant applications. Yes. There
 are plans to establish a Sub-Committee to specialise in fund raising. RADSPA is targeting
 further grants from local and Commonwealth sources

There being no further business the Meeting was closed at 8.10 pm
